




General Survey

The Year saw a hardening of unfavourable trends that are likely to persist in the foreseeable future. The Dutch government is gradually shifting part of the burden of the social security system towards the workplace, while public funding for research and education is on the decline, notably in the arts. Thus, in different ways, IISH's basic income has decreased by several percentage points over the past two years. The Institute has certainly been fairly successful recently in obtaining third-party funding, but this is also becoming more difficult: some European programs to which we applied proved to have attracted many thousands of contenders for relatively small amounts of grant money.

Developments in the Russian Federation, a focal point of IISH's activities, were not encouraging either. Sadly, our prediction that conditions for the study of history would steadily deteriorate is proving all too true. At year's end, many archives, libraries and research institutions in Moscow were on the verge of collapse and the brief spell of liberal access to historical documents was withering away under pressure from decidedly unpleasant forces. Western aid programs, if they exist at all, tend to concentrate on science. The academic infrastructure is neglected by Russians and foreigners alike, and risks irreparable damage.

Considering that we were not alone in encountering these difficulties, however, the Institute did relatively well. Almost all sections were able to register solid progress in several fields, as this survey hopes to show. Thanks are due to a dedicated and competent staff for making all of this possible.

POLICY

Within the framework of a discussion on strategy, the Royal Netherlands Academy of Arts & Sciences asked its institutions to outline their long-term policy. In June the Institute submitted a paper analyzing its strengths (a good infrastructure in collections and research, an efficient and flexible organization) and weaknesses (problems of conservation, fixed costs eroding discretionary spending power). It examined opportunities (further extending its international scope) and threats (government expenditure cuts). Finally, noting increased competition for ever scarcer resources among research institutions and document centres, it concluded that IISH should continue to pursue its policy of fostering international cooperation.

The paper was not even finished when the perceived threat became a reality: funding of the Royal Academy was curtailed by a significant amount. As a result, the Institute lost f175,000 (us\$90,000) in annual income and was forced to cancel two staff appointments, one each in the Research and Collections departments. The national budget for 1994, presented in September, contained an even more serious further reduction of the Academy's financial means. By the end of the year, however, parliament seemed unwilling to approve most of it and the question was shelved, no doubt for consideration by the new government that is to take office next year.

Meanwhile, in August, a survey of IISH's position as a collecting institution had confirmed its importance in the Netherlands. Both the Institute's archives and its library holdings rank among the ten or 15 largest in the country; its photograph collection comes second or third, and its posters are unparalleled. Management of these treasures appears to be cost-effective. To cite just one example, for every 100m¹ of accessions we employ half to a quarter of

the staff of comparable state and municipal archives. On the other hand, the funds we have available for acquisitions in all fields are easily eclipsed by the library budget of Amsterdam University's Law Faculty.

A second survey, still in progress, aims at broadening the range of services provided by the Institute. So far, we found little support for much-vaunted claims that this is the way to generate income. More often than not accounting costs alone suffice to wipe out all fictitious profits that briefly appear in one's bank account, whereas factoring in overhead and depreciation results in prices that no historian will pay. In other words, once a certain service is offered, it may be most economical to offer it for free. By the same token, though, the quantity and quality of services are obviously limited by the extent to which IISH succeeds in trimming the costs of its basic operations.

In a report on preservation, presented in October, we made an effort to substantiate our earlier claim that large-scale microfilming is the only sensible option we have left for coping with the problems caused by the progressive decay of late 19th and 20th-century paper. For the Institute, filming is from 15 to 40 times cheaper than various forms of restoration and repair. Even so, present means do not permit the much higher rate of production needed to make any real progress. A commercial approach is indicated.

The Institute's social policy will be the subject of another paper, which was being finished in December.

Within the Royal Academy, those institutions that might be labelled 'information providers', among them IISH, decided to expand their mutual links. Together they hold a large amount of valuable data on such diverse topics as medical literature, Indonesian linguistics or current research in social science. In addition, most of them are experienced in information technology. Closer cooperation is bound to yield results.

On I July, after almost ten years of incessant activity at the top, Eric Fischer left us to take up the position of director of the Dutch Union of Insurance Companies. He was hired in January 1984 to oversee the reorganization decided by the Institute's Board in the previous year; in July 1987 he was appointed general director. A trained economist, Dr Fischer set the organization on an entirely new foundation, greatly improving performance. Among his major achievements are the introduction of automation in 1987 and the move to a new building in 1989. Jaap Kloosterman, his deputy, succeeded him on 15 October.

INTERNATIONAL RELATIONS

The Institute continued to give special attention to developments in Eastern Europe, particularly in the Russian Federation, for which the Dutch Organization for Advanced Research (NWO) again provided generous financial support (see box). Our Moscow Office, headed by Irina Novičenko, proved invaluable.

Cause for exceptional satisfaction was the fact that IISH managed to bring the former Institute of Marxism-Leninism's library in Moscow, one of the world's best collections of books on labour history, under the aegis of the Ministry of Culture's state library system. Following the collapse of IML in August 1991, the library had simply been 'forgotten' and as it was now without legal status, had no sources of income. By taking responsibility for salaries and replacing part of the inventory which had 'disappeared', we were able to support our colleagues in Moscow for a year and in the meantime search for ways to solve the legal problems that had arisen around the organization and its building. On June 15, the library under a new name - Social-Political State Library - was reopened by Tat'jana Nikitina, the Russian deputy minister of Culture.

Already good relations with the former Central Party Archive, also once part of IML, but nationalized in August 1991 and renamed the Russian Centre for Preservation and Research of Modern Historical Documents (RCCHIDNI), were tightened. The heavy budgetary cuts imposed on this and other Moscow archival institutions in the spring led us to provide financial help so that the Centre could remain open to the public during the transition phase. At the same time, a start was made on the exchange of microfilms of archives which would complete both collections, particularly those on 19th-century German and Russian Socialism. Parts of the Communist International records concerning Turkey were also filmed for IISH. Furthermore, the Institute paid for the publication of the Centre's Naučno-Informacionnyj Bjulleten' and, with the Fondazione Giangiacomo Feltrinelli (FGGF) of Milan, for indexing of the records of the Communist Information Bureau, the successor of the Comintern. We again invited a delegation of archivists from the Centre and the Russian State Archive to tour the Netherlands' archives.

A third extensive project concerns the filming of the archive of the Memorial Documentation and Research Centre in Moscow, which has accumulated a major collection on the victims of state terror in the Soviet Union. The Institute donated film equipment to make the project possible. Moreover, we financed a number of research projects carried out by Memorial. Of the numerous other projects supported by IISH, we may mention the filming of a highly interesting collection of newspapers produced in Soviet camps since the 1920s and found in a top secret section of the State Archive library. Here again, the Institute donated reproduction equipment.

Although ties with Rosarchiv, the Russian Ministry of Archives, were further improved, no progress was made on the return of the Institute's materials that were removed by the Germans during ww 11 and later fell into

Soviet hands. After the war, the documents were placed in the so-called Special Archive by the state security service; so far, IISH archive collections have been identified in both the Dutch and German sections. The latter includes the Joseph Bloch papers (in fact, the archive of the *Sozialistische Monatshefte*), which was purchased by the Institute before the war. Rosarchiv's influence on the restitution of material is, in fact, limited – the archives have become a political pawn.

At the request of the Hoover Institution in Stanford, IISH participated in preparations for the computerization of sections of Russian archives, in which the American Research Libraries Network plays a leading role. The project, in cooperation with Rosarchiv, is slated for commencement in 1994.

We did not succeed in finding substantial funding for archives and libraries in the Czech Republic. As noted in last year's *Annual Report*, after a brief surge at the end of the 1980s, Western interest in this part of Europe is on the decline, at least in our field. As a result, the Prague Office created by the Bibliothèque de Documentation internationale contemporaine (BDIC), FGGF and IISH has not been able to develop as we hoped. Still, together with our colleagues from Nanterre and Milan as well as Paris' Maison des Sciences de l'Homme (MSH), we were glad to support the start of an information project on emigration from the former Soviet Union to Czechoslovakia, undertaken by Prague's Slavonic Institute.

Our involvement with the Institut für zeitgeschichtliche Jugendforschung (IZJ), referred to in last year's Annual Report, was reduced somewhat after the embattled institution decided in principle to transfer the records of the former Free German Youth organization to the semi-independent Berlin subsidiary of the Bundesarchiv. Predictably perhaps, IISH was much abused for its effort to keep the archive accessible, as there were those who insisted on

interpreting this – in the face of all evidence – as a takeover of German cultural heritage by a foreign intruder. Obviously, we have considered the chosen solution to be the most appropriate one from the start; it would undoubtedly have been reached long ago but for the peculiar way in which negotiations proceeded.

Relations with the International Association of Labour History Institutions (IALHI), the International Council on Archives (ICA), the International Federation of Library Associations and Institutions (IFLA) and the Fédération internationale d'Information et de Documentation (FID) continued as usual. As in previous years, numerous Dutch and foreign colleagues visited the Institute to take a closer look at its system of automated access, especially to pictures.

SOCIAL SURVEY

On December 31, 1993, 104 personnel were employed at IISH, of whom 73 percent had tenure – or the prospect of a permanent position – with the Royal Academy. In 1993, we made relatively extensive use of the job-pooling option for the first time. Four employees were appointed for indexing projects, while five job-poolers found work on the Sampling Dutch Population (HSN) project. Experiences were positive, especially at the latter.

Around 65 percent of staff work full-time, while just under 84 percent work three or more days per week. The male/female ratio is 55/45, with a fairly even balance up to salary scale 11. In higher scales, only men are employed (4 in 12 and 3 in 14). The average age is around 40, and a comparatively high number of employees (22 percent) is between 40 and 45 years old.

Time lost through illness was an average 7.3 percent for permanent staff of the Royal Academy, which, though not particularly worrisome, is above the Academy's average (4.8 percent). If staff who have been ill for longer than one year are excluded from the calculation, our average is 5.9 percent.

Anticipating the social policy plan due to be implemented in 1994, the Institute introduced a number of measures during the reporting year. In consultation with the Staff Council, an internal premium system was agreed. Part of management followed a training course on how to conduct staff evaluations. In future, these evaluation meetings with all members of staff will take place annually in February-March.

Even more attention was given to staff training than previously. A total of 16 staff attended 21 courses. Costs amounted to $f_{36,000}$. A relatively new development was attendance at management training courses alongside the more professionally oriented ones.

Once again, an important contribution to the personnel's welfare was made by the 'Lief en Leed' (Love and Sorrow) committee, which provided flowers, cards and gifts for births, marriages, PHD celebrations, departures and staff who were ill. The personnel association was also active during the reporting year and organized, among other things, the now traditional Christmas breakfast and the farewell party for Eric Fischer. Five staff parties were organized in 1993, ideal occasions to say goodbye to departing staff and welcome new colleagues.

COLUMN I

The main inflow (around f6.8m) comes from the Royal Academy, which finances the Institute's fixed staff costs and daily operations. At year end, operations showed a slight positive balance.

In addition, third-party funded projects were carried out with a value of around f1.5m. These included emergency actions financed by NWO in the former Soviet Union as well as the HSN project.

The IISH Foundation provides structural funding amounting to fo.5m intended for additions to and maintenance of the collection. Besides these funds, the Foundation carried out the Visual Information project - the digitizing of the iconographic collection - which is being financed by the Ministry of Education & Sciences.

Acquisitions

POR THE COLLECTIONS DEPARTMENT, the reporting year was a period of reorientation. Its main points had been set out in a memorandum, Stronger With Less, published at the end of 1992. In the course of 1993 the main conclusions were to be effected: the reinforcement of IISH's position as a collecting body and a more efficient management. More than in the past, acquisition is to be focused on core elements in the collection. One consequence was that in comparison with previous years, a very critical approach and great reserve was exercised in the acquisition of books and periodicals. This also applied to archives and collections, whose number declined, though this was not obvious in terms of size.

Besides a reorientation in acquisition policy, the processing of material already obtained formed a priority. During the reporting year, a vigorous start was made in this area in close cooperation with other IISH sections.

Furthermore, during the second half of 1993 we started a structured evaluation of policy per geographical collection area. In November and December, the experts concerned began discussions on a new approach, following the publication of a first profile sketch concerning Latin America. Once this discussion is completed other collection areas will be tackled in a similar fashion.

In previous years, our *Annual Report* contained an almost complete list of acquisitions. Since these will soon be available online, we now terminate the practice and mention only the most important acquisitions. For a comprehensive overview of 1993 accessions, readers may also consult the *International Review of Social History*, or the *Tijdschrift voor Sociale Geschiedenis* for Dutch acquisitions.

THE SZYSZKO PAPERS

* The Mariusz Szyszko collection, acquired in 1993, comprises 1,776 books and brochures published by the Polish opposition movement between 1970 and 1990. The majority are Solidarność publications from both Warszaw and the provinces. In addition, the collection includes publications of other political and social movements, critical academic groups and the Catholic opposition.

* Forty percent of the collection concerns topical political and social subjects; over 10 percent is historical and a quarter committed literature. Almost half the titles appear in the bibliography by J. Kamanska on Polish opposispirator for 'Germany's unity and freedom' in 1824. After he was set free in 1830, he became a lecturer at Halle university. He was converted to Hegelianism, and - well off through his first marriage - created a platform for Young Hegelian phi-

losophy and politics with the Hallische and Deutsche Jahrbücher, (1838-1841, 1842-1843). Both journals were suppressed by the Prussian and Saxon governments. In Paris his short-lived co-operation with Karl Marx resulted in the Deutsch-Französische Jahrbücher (1844). In 1848, he was elected to the Frankfurt Parliament as member for Prussian Breslau and founded the democratic daily Die Reform. He moved it to Berlin, and saw it banned by November. Defeat of the revolution forced him into exile in Britain. There he participated in the dreams and quarrels of exiled Germans and the international democratic movement in the 1850s, and finally made peace from a distance with Bismarck's Reich in the 1870s. He lived in Brighton until his death in 1880.

* The majority of Ruge's papers was lost in Germany during ww 11. This fragment (0.25 m) was preserved by descendants of his son Herman A. Ruge in the USA. Correspondence between Arnold Ruge, his second wife Agnes, their children and their

parents shed light upon the ways of this family of intellectual migrants from the thirties to 1880, sometimes with surprising sidelights; eg on the Ruge-Marx-'cohabitation' in Paris in 1844. Arnold's early years are treated in a manuscript of his reminiscenses, their British exile in those of Agnes. From the latter period date manuscripts, notes and documents by Ruge as well as interesting specimens of his correspondence with former authors of the Jahrbücher, revolutionary companions of 1848, and fellow exiles from Germany and other countries.

* In 1969, the psychologist Carel Muller was appointed director of the mental health care department. In the succeeding years he introduced innovations, many of which have since become established practice. However, the rapid and radical changes led to a conflict with the hospital's administrators and division among the staff. One national newspaper, De Telegraaf, began publishing sensationalist stories. Public interest was raised and this in its turn led to political discussions, enquiry committees and, finally, Muller's dismissal.

lection (about three metres) originates from Carel Muller and (primarily) from Jet Douwes who was on the hospital staff. It comprises chronologically arranged albums, the most important documents, including minutes and correspondence (collected with a view to publication), Nieuw Dennendal log-books, notes and impressions. In addition, it also contains sound tapes, posters and photos (partly from Han Singels) and drawings by pupils. They provide a moving record of the pupils' trips, the community and especially the dramatic clearance of the

In addition to the Russian materials referred to earlier, a collection of Polish underground printed matter, 1977-1990, was a very welcome supplement to our East-European holdings (see box). Together with the acquisition, also in the reporting year, of the papers accumulated by Jan Minkiewicz, Solidarność's representative in the Netherlands, the development of Poland in the 1980s is now far better documented.

The most important acquisition on Latin America, especially when seen in the context of the profile sketch, is undoubtedly the collection originating from the Partido Comunista Mexicano, which was accumulated by Enrico Condes Lara. It consists of an archive and printed matter covering the period from 1919 up to the 1980s. It will be shipped to the Netherlands in early 1994. The filming of the records of the Federación Nacional de Trabajadores Mineros, Metalúrgicos y Siderúrgicos del Perú, in collaboration with BDIC and FGGF, also meshes with the adjusted collection aims.

More or less by chance, we were able to acquire part of the records of the Türkiye Komünist Partisi (TKP). This section, located in Duisburg, contains the post-1960 archives and a collection of TKP publications. The Institute will, of course, continue its attempts to acquire the other section, which was moved to Russia at the end of the 1980s, but it is uncertain whether this can be achieved in the short term. The above-mentioned films of material concerning Turkey from Moscow's Comintern archive will be available in Amsterdam in early 1994.

Other remarkable accessions were a part of Arnold Ruge's archive (see box) and a microfilm of the papers of the Russo-American Trotskyist activist Raya Dunayevskaya (1910-1987), who donated her archive to the Wayne State University of Labor and Urban Affairs in Detroit. Mention should also be made of the records of the Vereinigte Sozialistische Partei, of Hamburg. Besides a small ar-

chive, the collection consists mainly of pamphlets and periodicals and is also of importance for the ID-Archiv im IISG.

Among other non-Dutch acquisitions, we may draw special attention to the Solidarity records. This organization was set up in 1960 after a split in the Socialist Labour League. Its archive spans the period 1960-1983 and, besides periodicals published by Solidarity, contains correspondence from Ken Weller, Heather Russell and other members of the London group with kindred spirits in the United Kingdom and elsewhere.

As a repository for international organizations, we received a substantial supplement to the records of the International Confederation of Free Trade Unions (ICFTU). Besides printed matter and archive material, the collection received comprises large numbers of films, audio-tapes and grammophone records (see box). The European Trade Union Confederation also provided a supplement to the records deposited with IISH in 1991.

The Institute also acts as a repository for the archives of various Dutch organizations. During the reporting year, we received supplements to the records of the Industriebond FNV (Industrial Union) and the Partij van de Arbeid (PVDA, Labour Party). The parliamentary PVDA archives and those of the Evert Vermeer Foundation deserve special mention. The records of the Pacifistisch Socialistische Partij were expanded substantially, partly as a result of the publication of Sporen van Pacifistisch Socialisme. This book comprises not only an inventory of the archive and an overview of all the locations of PSP archives in the Netherlands, but also data on publications and visual material. It is a joint publication of 11SH and the Dutch Centre for Documentation on Political Parties in the Netherlands. Furthermore, additions to the papers of Henk Sneevliet, Johan W. Albarda, Henri H. van Kol and many others were deposited with the Institute. J.A. van Kemenade donated his files on the Den Uyl succession.

THE ICFTU RECORDS

- * An important supplement to our international archives was obtained through the acquisition of the records of the International Confederation of Free Trade Unions (ICFTU), complementing an earlier section of its records already present in the Institute.
- * The ICFTU was founded in 1949 as a counterpart to the World Federation of Trade Unions, which was increasingly falling under Communist influence. Among the main organizations involved in the formation of the ICFTU were the American Federation of Labor (AFL), the Congress of Industrial Organizations (CIO), the British Trades Union Congress (TUC) and the Nederlands Verbond van Vakverenigingen (NVV). Headquartered in Brussels, in 1991 the ICFTU totalled 143 affiliated organizations in 100 countries with a total membership of 102 million.
- * Through its worldwide activities on behalf of trade union rights the records bear a unique testimony of the struggle by trade unions, often in very difficult and even dangerous-circumstances. Support was given to the Confederation of Turkish Trade Unions Türk-Is, to Solidarność in Poland and to the Congress of South African Trade Unions (COSATU), to mention just a few.
- * At the same time the documents provide information on wages, working conditions, labour legislation, insurance or industrial conflicts in widely different countries, such as Japan, India, Peru, Germany, Mexico, China, the United States and Morocco.

- * In addition to the documents relating to congresses, the Executive Board and the regional ICFTU organizations in Africa, Asia, Europe and America, which were partly already present at IISH, the importance of the newly acquired section lies in the extensive correspondence with all the ICFTU's affiliated organizations, including Landsorganisationen i Danmark, the Federation of Korean Trade Unions (FKTU), the Confederación General del Trabajo de la República Argentina, the Canadian Labor Congress, the Union marocaine du Travail (UMT), the Nigerian Labour Congress (NLC), the Hind Mazdoor Sabha from India and the Japanese Trade Union Confederation (JTUC-Rengo), their predecessors as well as affiliated unions.
- * The size of the entire ICFTU archive is c 230 m. In due time supplements consisting of the records of later years may be expected. Together with the archive we received the ICFTU film collection, visualizing workers' problems trade unionists all over the world are dealing with.
- * As it also covers countries which were less well documented, the ICFTU archive constitutes one of the core collections of the Institute offering visitors ample opportunites for comparative research on trade unionism.

Further fine acquisitions included the Nieuw Dennendal records (see box) and the archive of the squatted Tetterode building, documenting how people lived and worked there for years. The collapse of Communism in the Soviet Union and the disappearance of the German Democratic Republic brought the end of the Netherlands-GDR Association and the transfer of its archive to the Institute. W. Hulst deposited his own collection and a major part of the Association's archive.

The Image and Sound Section was again successful in acquiring interesting and important collections. Mention has already been made of the audio-visual material from the ICFTU. In addition, the PVDA, the Socialist daily Het Vrije Volk and the Communist newspaper De Waarheid all donated a large number of photographs. We received flags and banners through a number of organizations including the National Trades Union Museum and the German Vereinigte Sozialistische Partei.

The poster collection was supplemented by the purchase of 25 top pieces from the collection of Steef Davidson. These comprise extremely rare and unique Russian posters from the period 1918-1939 including three election posters of the Partija Socialistov-Revoljucionerov.

s usual, listing of archives and collections focussed Λ on keeping pace with material inflows. During the arrangement, material to be preserved was selected extremely carefully so that the net growth of the archive collection was considerably lower than the gross size of the accessions. Two extensive projects were rounded off this year. One milestone was the completion of the inventory of the important records of the Sozialistische Arbeiter-Internationale (Labour and Socialist International, 1923-1946), which had been in progress, with interruptions, since 1959. Furthermore, the inventory of the papers of the Dutch Socialist leader and prime minister, J.M. (Joop) den Uyl, was completed. The inventory's presentation and opening attracted great attention in the Dutch media (see box). The personal papers of the Socialist and Feminist writer Dora Russell-Black, Bertrand Russell's second wife, were listed in a published inventory (IISH Working Paper 20).

A project for listing the former Dutch Communist Party's (CPN) records, mainly funded by the Prince Bernhard Fund, was completed. After transferral of the archive in 1994, the index will be published. Indexing of the records of the Pacifist-Socialist Party (PSP) was funded by the former party and, again, the Prince Bernhard Fund. As a result, the index of the party's records over the period 1957-1991 could be completed. The indexes were published in a source overview and bibliography of the PSP.

In total, the Archives Section produced over 50 lists and inventories (see box).

* Few personal papers are as complete as those of the Dutch Social-Democrat leader and Prime Minister, J.M. den Uyl (1919-1987).

* The files give a good insight into the key role Den Uyl played in Amsterdam's munic-

He preserved nearly everything. He consulted his papers constantly and kept them up to date.

* From the early 1960s until his death, Den Uyl kept a 'political diary': he made notes of everything that was said during meetings, debates, conferences and conversations, often including his own words, mostly without comment. It seems as if he used these notes as his memory.

* They constitute the backbone of his papers: they refer to all the subjects of the files grouped together by Den Uyl. In these files he kept everything concerning matters in which he was engaged during the exercise of his many duties,

ipal policy during the 1960s, in parliamentary history from the 1950s until the 1980s, in the post-war Dutch Labour Party (PVDA), in international Social-Democracy, and in European policy. But also there are files relating Den Uyl's active life as a student (1936-1942) and his membership of the editorial staffs of Het Parool en Vrij Nederland in the period 1945-1948.

* The original order was a good starting-point for the arrangement at IISH. The files have been described in an inventory; in addition correspondents and lectures on hand in the files have been indexed. The Den Uyl papers

coverage was extensive: all newspapers and most television stations paid attention to it.

THE LIBRARY

The Library Section is responsible for ordering and cataloguing books and periodicals. It thus forms a link between the acquisition specialists and the Reading Room. In the Section, the specialists' requests for publications are transformed into orders from either booksellers or the publisher. The books supplied and the incoming issues of journals are registered on arrival along with their invoices. Subsequently, the publications are catalogued so that they can be retrieved through the online public catalogue. The Section also handles publications reviewed in the *International Review of Social History*.

Besides purchase, publications are also given free of charge to the Institute or are exchanged for our own publications. Occassional gifts, but also larger collections find their way to IISH. All of them are made accessible for our users. In 1993, the Section catalogued 10,183 books and 2,928 periodicals; 13,101 new records were input into the online public access catalogue, bringing the total to 665,818 at the end of the year. A few periodical collections which had been in house for some time were also catalogued. No less than 55.6 metres were processed, resulting in additions to the collection of 727 new periodical titles and supplements to 888 already present titles.

A total of 5,869 new orders were placed. In addition, we received 5,155 books, of which 383 were for the *Review*. Current subscriptions brought in 19,284 issues. In total, 24,439 items were registered in the acquisition system. The number of entered invoices for books and periodicals was 1,199 for both.

In the reporting year, the ID-Archiv's current subscriptions were input, thus adding around 700 titles to both the acquisition system and the catalogue. This means this section of the ID-Archiv retro-project has been rounded off.

THE IMAGE AND SOUND SECTION

Following input of the photograph collection between August 1989 and the end of 1992 (over 78,000 items), a start was made on the poster collection in 1993. This collection consists of around 50,000 items and in terms of size is the largest in the Netherlands; it is also one of the best in terms of quality. Within the framework of the Visual Information project, we received additional subsidy for entering the descriptions of 37,000 posters in the bibliographic database and for digitizing the images. The project should see completion in 1994. In the reporting year, over 19,000 posters were described and 10,000 images recorded. This means that the Dutch and German poster collections can now be consulted by computer.

Services

I N 1987 IISH INSTALLED its first computer system for bibliographic information, a GEAC package that helped us triple cataloguing capacity and provided users with an online public access catalogue containing all former card catalogues of printed matter and part of the catalogue of photographs, which is being added to the database, pictures and all, since 1989. Yet financially and technically the system had been written off and in 1993 IISH chose GEAC'S Unix-based Advance product as a replacement to be installed in Spring 1994. The new OPAC will be much enhanced. A search for a specific material type or special collection will henceforth be menu-driven. So-called Boolean operators - terms like 'and', 'or' or 'not' that broaden or narrow the requested set of data - may be used to refine searches. Another feature will improve access to IISH's old classification: though this will be phased out eventually, it will long remain an indispensable tool since it has been applied to some 350,000 monographs. Archival data is being prepared for input. And once the system is in place, we will connect to SurfNet, the Dutch academic network, itself linked up with the Internet. In other words, the OPAC will be accessible from any modem across the globe. Other services are being contemplated. A grant from the Royal Academy enabled 115H to explore the opportunities offered by scanning and optical character recognition. The Netherlands Historical Data Archive is currently experimenting with desiderata such as the conversion of bibliographic and biographical data or a 'current contents' service. If anything comes of it, it will be put at the disposal of OPAC users wherever they are.

Preservation

During the reporting year the 'collection preservation group' set up in 1992 gave special attention to a 69-metre collection of Anarchistica. The main point was to devise an adequate method of packing. Around 30 percent of those pamphlets and paperbacks not eligible for restoration were packed into acid-free carton cassettes.

Besides the usual preservative treatment of pamphlets by the Tiendschuur restoration studio in Tilburg, a number of posters and prints were also restored successfully. Book and journal binding was again entrusted to Schrijen of Susteren.

Microfilming was continued. Filming included Nettlau's memoirs (*Erinnerungen und Eindrücke*), the first half of the Partija Socialistov-Revoljucionerov's records and pre-war Italian newspapers. IDC Leiden took on the filming of the Tian'an Men collection. This collection of pamphlets, periodicals, photos etc generated by the Chinese democratic opposition in 1989 will come onto the market in 1994.

Research

RESEARCH

Research in the institute was both strengthened and streamlined. Added strength came in particular from increasing the appointment of Erik Zürcher; from the PHD degree conferred by the University of Braunschweig on Jürgen Rojahn; from the appointment of a second PHD-student; and from a number of contract research projects the Department was able to acquire. Streamlining was fostered in the fields of both source editing, a long-standing tradition of the Institute, and analytical research.

As to the publication of documents from our archives, Dr Rojahn completed his edition of the voluminous memoirs of Wilhelm Dittmann, a member of the 1918 German revolutionary government. The text will be published by the end of 1994. It is an important source for the history of German social-democracy from the early 1890s up to 1933, especially for the debate within its parliamentary group during ww I.

Zdeněk Šolle edited Karl Kautsky's correspondence with the Czech and Slovak lands, in cooperation with Jan Gielkens (see box). The text of the correspondence between Henriette Roland Holst and Henk Sneevliet, annotated and introduced by Fritjof Tichelman with the assistance of Nico Markus, was almost finished. The source publication on the Indonesian Social-Democratic Association (ISDV) by Dr Tichelman, with the assistance of Emile Schwidder, is also expected to be finished next year. The publication of documents on the history of the Socialist International during ww I, which is being prepared by

изн (co-ordinator Dr Rojahn, assisted by Mr Gielkens), in cooperation with the Arbetarrörelsens Arkiv och Bibliotek in Stockholm, the Arbejderbevægelsens Bibliotek og Arkiv in Copenhagen and the Camille Huysmans Archief in Antwerp, was continued. The Thyssen-Stiftung offered substantial funding. The editors started work on part 2, covering the years 1917-1918.

Two major projects will dominate this field for the foreseeable future: the Marx-Engels Gesamtausgabe (MEGA) and the M.A. Bakunin Project. 1993 was an important year for both. Work on the MEGA was continued within the framework of the International Marx-Engels Foundation, or IMES (secretary Dr Rojahn, assisted by Ursula Balzer). In 1993 the newly created Berlin-Brandenburgische Akademie der Wissenschaften decided to join the Foundation, thus greatly enhancing its financial base. Under the aegis of IMES, volumes are now in progress in Russia, Germany and France. The Institute is well-represented on the Board and the Editorial Committee of IMES.

The Bakunin Project also made good progress (see box). As decided in December 1992 work was started on the publication of all documents written by the Russian revolutionary as images as well as in machine-readable form (both in the original and in a French translation whenever it was written in another language). Under the responsibility of Jan Lucassen, Bernedine Bos, with the assistance of Anke van der Moer, began digitizing the texts and a promising search for as yet unknown documents has begun.

Streamlining of analytical research gradually took shape through the further defining of a research policy focussing on four main fields of interest. We will concentrate on the history of labour and labour relations and, in particular, on the development of new concepts and theories through international comparisons. First among our fields is early modern and modern labour history of the Western World, for which Dr Lucassen and Marcel van der Linden are responsible. Second is the history of Socialism and Communism, under the responsibility of Dr Rojahn. Third is the labour history of the Third World, for which Dr Tichelman (Indonesia), Tony Saich (China) and Dr Zürcher (Turkey and the Middle East) are responsible. Fourth is the labour history of Eastern Europe, for which no fixed post is available at present.

In the first field, regarding the Western World, new research projects on labour organizations for mutual insurance were initiated (besides the PHD-project that started last year on the 19th century, a similar study on the 18th and 17th centuries has now got under way). Other new projects include female participation in labour unions and the relationship between geographical and social mobility. We held conferences - mostly in cooperation with universities in the Netherlands - on concepts and theories in the history of migration, notably labour migration (see box), on mutual insurance and on labour relations in guilds. Preparations for a conference on Free and Unfree Labour were made through the publication of a call for papers. The publication by Dr Van der Linden of a special issue of the International Review of Social History on 'The End of Labour History?' also fits well in our program (see below, 'Publications'), as does the research by two fellows the department welcomed this year: Richard Price, of the University of Maryland at College Park (USA), who stayed until August; and Ray Markey, of the University of Wollongong (Australia), who spent September at the Institute.

The history of Socialism and Communism is obviously well represented among our source publications. It was also furthered by Dr Rojahn's editing of the papers written for the 1992 conference on the Communist International, and his organization of another conference on the Communist Youth International. Ursula Langkau-

KAUTSKY AND CZECHOSLOVAKIA

- * Karl und Luise Kautsky. Briefwechsel mit der Tschechoslowakei 1879-1939. Herausgegeben von Zdeněk Šolle unter Mitwirkung von Jan Gielkens. Frankfurt/New York: Campus Verlag, 1993. 551 pp.
- * This source edition, which appeared as part 11 in the 'Quellen und Studien zur Sozialgeschichte' series published by Campus Verlag in cooperation with IISH, contains almost 500 documents. most of them never published before, from archives in Germany and the Czech Republic, but especially from the Kautsky archive in 115H.
- * After the death of Friedrich Engels, Karl Kautsky (1854-1938) was considered the most important exegetist and disseminator of Marxist theory. Through his parentage - his father was Czech, his mother German and he was born in Prague - Kautsky had particular ties with the Czechs, which is documented in all its aspects in the collected letters. The documents begin with the student Kautsky's involvement with the young Bohemian social-democracy; as writer and editor, Kautsky maintained numerous contacts with fellow writers (including the later Czechoslovakian president Masaryk), with people from the movement and with translators of his work; in his later years he became a patriarch for the Czech social-democrats (both German and Czech speaking) who had been actively involved in the new Czechoslovak republic from 1918, which had emerged from the complex Central-European state and nationality situation. Besides the documents, the edition comprises an

extensive foreword by Zdeněk Solle, a number of appendices and a bibliography of publications of Kautsky and his precursors' work in Czechoslovakia.

BAKUNIN ON CD-ROM

- * The Bakunin Project is one of the longer lasting projects of the Institute, initiated at the end of the fifties in order to present the unpublished writings of the Russian revolutionary Michail Bakunin (1814-1876). To date, the Archives Bakounine series consists of seven printed volumes in eight bindings, published between 1961 and 1981. Besides the writings of Bakunin in the original language, the publication contains French translations and some historical and bibliographical annotations. The publication of the remaining planned volumes ground to a halt and although the project continued, no new volumes have been published since 1981.
- * In 1988 it was decided to try and publish the complete works of Bakunin and to look for further funding. This was achieved to a certain extent in 1990, when the Royal Academy decided to allocate funds for the project in order to finish it within a few years.
- * In 1992, a feasibility study showed that a publication of the texts without the usual annotations on CD-ROM would allow completion of the project within the limitations imposed by the new budget. This would also give us the challenge of trying out newly developed techniques for historical publications. It would allow, for example, the publication of images of Bakunin's handwriting.

* The CD-ROM edition will publish the original manuscripts or, in case they are lost, the first printed edition. With the help of windows the user will be able to retrieve the text, a French translation and the image on the screen at once. The edition will be published in 1996-1997.

MIGRATION AND SETTLEMENT

- * In cooperation with the University of Leiden, our research department organized a three-day conference on 'Migration and Settlement in a Historical Perspective'. During the first two days (23-24 September) some 25 specialists from seven different countries in Europe and North-America discussed new concepts and theories in the field of migration history, and in particular of labour migration. Four topics were debated at length on the basis of precirculated papers: the problem of periodization of migration history of the early modern and modern periods, negative and positive roles of the nation state in the process of migration and settlement, the relationship between free and unfree labour migrations and the positive and negative role of the labour movements. Revised versions of the papers as well as a substantial introduction which summarizes the debates and the ensuing conclusions will be published by the Institute.
- * The final session (25 September) was devoted to the theme of the 'Importance of the Migration Factor in History Teaching at Secondary Schools in Europe'. This day, in which reports on current developments in France, Germany, Britain, Belgium and the Netherlands were presented, was chaired by Fritz Wittek, of the European Commission in Brussels.

Alex succeeded in obtaining funding for a project due to start in March 1994 under the title 'Von der Diktatur zur Demokratie: Ideen und Modelle zur Umgestaltung Deutschlands in der sozialdemokratischen/sozialistischen Bewegung nach 1933 in internationalem Vergleich'.

Regarding the labour history of the Third World, much work was done by Dr Zürcher, who organized two seminars on 'The Development of the Industrial Workforce in the Ottoman Empire and Turkey 1850-1950' and 'Trade unions, immigration and immigrant workers in Western Europe 1945-1993'; for more details, see below, 'The Turkey Section'. We further agreed with the University of Amsterdam that the holder of the new chair on the history of South and Southeast Asia – to be appointed next year – will devote two days a week to labour history within the framework of the Research Department of IISH.

Although attempts to find funding for a research post on East-European labour history have so far failed, we continued efforts to further this field of research. Foreign specialists in East-European history have taken an active part in many of the Institute's comparative projects.

PUBLICATIONS

All publications by IISH staff are listed below in the Appendices. The reporting year was fruitful: about every second working day one of our staff published a book or an article, or read a conference paper.

The International Review of Social History completed its first year (vol 38) at the Cambridge University Press (CUP). The first of a series of annual supplements, which are simultaneously made available in book form, was titled 'The End of Labour History?' and edited by Marcel van der Linden. It addresses some of the obstacles to an integrated social history of labour as identified by Dr

* In his 'Editorial' prefacing the first regular Supplement to the International Review of Social History, Marcel van der Linden outlined a programme to integrate labour history with other historical perspectives.

He summarized his criticism of existing practice as follows:

- * (1) Geographical, spatial, and environmental circumstances [...] have been neglected. Labour historians tend to view space as something 'dead' (Michel Foucault) and therefore often fail to give ecological and locational influences on human actions the consideration they deserve.
- * (2) There is a contrast between the history of daily life and institutional history. It is necessary to bridge the gap between historical research on objective events such as labour processes, wages, and housing on the one hand and research on individuals' subjective experiences regarding these issues on the other. A true understanding of these developments is possible only when the objective and subjective aspects are viewed as interdependent.
- * (3) Research currently isolates the working class and the workers' movement to the exclusion of outside influences. The theory that it is necessary to consider trends such as the history of entrepreneurs when writing about labour history should be applied in practice.
- * (4) Issues involving gender, race, ethnicity, and age are treated as separate subdisciplines. Although labour history research no longer appears to focus implicitly on young white male workers, it remains diffi-

cult to find a consistent approach to the plural identities of the working class.

- * (5) Misleading periodization persists. Two methods of exclusion by date have had an artificial and consequently distorting effect on labour history. Developments of the early modern period are all too often considered isolated incidents (although periods analysed are beginning to start around 1700 instead of around 1800). Labour historians are insufficiently aware of the importance of the development of merchant capitalism in places such as Florence during the quattrocento or the Republic of the Netherlands during the sixteenth and seventeenth centuries. Furthermore, analyses of very recent labour relations and labour movements from the past two decades are usually the domain of scholars from other fields (such as industrial relations or sociology).
- * (6) Labour history research overemphasizes core countries such as the United States. Canada, Western Europe, and Japan. The burgeoning labour history of the capitalist periphery merits the same consideration as the labour history of the core countries. Whether developments occur in Chile, Nigeria, India, or Malaysia, they deserve to be studied as events in their own right, rather than as early stages of or deviations from developments in highly developed countries.

Van der Linden (see box). Further supplements will examine other problems on his list. Jan Lucassen is preparing an issue on periodization, due to appear in 1994.

A printed index to volumes 1-37 of the IRSH was made available through CUP.

EDUCATION

Although we have no formal teaching programs of our own, the staff of IISH's Research Department is involved in all sorts of academic teaching.

First, Jan Lucassen gave his courses at the Free University of Amsterdam, where he holds a private chair – established by IISH – in international comparative social history. Tony Saich is ordinary professor of modern Chinese history at the University of Leiden, and Erik Zürcher is associate professor of the history of the Middle East at the University of Nijmegen. At the end of the year, Dr Zürcher received his appointment to a second IISH private chair, this time of Turkish and Ottoman history at the University of Amsterdam.

Second, staff members of the research department are active in the training programs of the N.W. Posthumus Institute (see below, 'Related Institutions') as well as in other similar activities.

Last but not least, the Institute has taken the initiative to start PHD courses in labour history in Moscow. Preparations are still under way, but the prospects are good; the first course might even start in the Fall of 1994.

Exhibitions

The institute offered exhibition space for 'Grenz-überschreitungen', on the life and work of Walter Benjamin (16 September to 15 October). This exhibition was created by Konrad and Ingrid Scheurmann of the Arbeitskreis selbständiger Kulturinstitute in Bonn. It formed part of a larger program; there was a complementary exhibit in Amsterdam's Stedelijk Museum showing work by the artist Dani Karavan, which included a design for a memorial for Benjamin in Port Bou. In the same period, the Goethe Institute in Amsterdam organized lectures, and the Desmet film theatre showed films on the philosopher and writer.

Special Sections

THE TURKEY SECTION

W HILE THE ACQUISITION OF the TKP archives mentioned above has of course taken up most of everybody's time and attention, collecting printed materials continued as before. Three consignments of books and periodicals from Turkey reached us over the past year, totalling some 800 titles, including several gems, such as five volumes of the Aydınlık Külliyatı published in 1923-1924.

As in preceding years, the Section organized two seminars. In April, the group working on 'The Development of the Industrial Workforce in the Ottoman Empire and Turkey 1850-1950', led by Donald Quataert (SUNY Binghamton) met for the second time, for further discussions. The participants – Sherry Vatter (Los Angeles), Feroz Ahmad (Boston), Çağlar Keyder (Binghamton), Şehmus Güzel (Paris), Erdal Yavuz (Ankara) and Yavuz Karakışla – had been requested to make changes to their papers, following the first meeting of the group in March 1992.

The second seminar, held in November 1993, dealt with 'Trade Unions, Immigration and Immigrant Workers in Western Europe 1945-1993'. This is a joint project with the Institute for Migration and Ethnic Studies of the University of Amsterdam, whose director, Rinus Penninx, is the project leader. Other participants were Judith Roosblad (Amsterdam), August Gächter (Vienna), Jan Vrancken (Antwerp), Peter Kühne (Dortmund), H. Hoffmann-Nowotny (Zürich), Cathie Loyd (Warwick/ Coventry), John Wrench (Warwick/Coventry) and Wuokko Knovke (Stockholm).

During this meeting the research agenda was set. The

participants will contribute case studies on the different countries of Western and Central Europe, revolving around the threefold dilemma faced by the trade unions: resistance to, or acceptance of immigration; inclusion in, or exclusion from the unions of migrant workers; and equal treatment of, or special policies for migrant workers. The second meeting will be held in 1994.

Apart from these two specialist workshops, IISH has been busy preparing the 11th International Congress of Turkish Studies (CIEPO), which is organized jointly by the Institute and the universities of Leiden and Nijmegen and will be held in Amsterdam in June 1994. The response to our circulars has been very encouraging, some 130 people having announced their intention to participate.

Publication of the results of the first series of workshops on 'Socialism and Nationalism in the Ottoman Empire' was originally foreseen for early 1993, but has been delayed somewhat. The book (a collection of six major articles on the subject with an introduction and a conclusion) will now definitely appear at I.B. Tauris in 1994. The publication of the results of the workshops on the 'Development of the Industrial Workforce' is foreseen for the Autumn of 1994.

Work on the biographical dictionary, which had been stalled for some time, will restart in January 1994, but the format of the project has been changed: instead of dealing only with politicians of the period 1908-1926, the work will now include people from other fields (business, labour, arts, law, science, religion etc.) and cover the period from 1908 to 1990. The work (not due to be completed until 1997) will now be edited jointly by Erik Zürcher and William Hale of the School of Oriental and African Studies of London University, with contributions from a much larger number of specialists than originally envisaged.

THE ID-ARCHIV IM IISG

Since June 1988, the ID-Archiv has been located in IISH. The archive was created in 1981 and is based on the Frankfurt weekly *Informationsdienst zur Verbreitung unterbliebener Nachrichten* (ID), 1973-1981. It presently comprises a collection of 5,000 alternative periodical titles, of which more than 700 are current. In addition, the archive includes a large collection of brochures, pamphlets and posters and some small archives (Antiimperialistisches SolidaritätsKomitee, Knastarchiv, Archiv Zensur in öffentlichen Bibliotheken).


Two important collections acquired during the reporting year should be mentioned (besides four small ones) – the poster collection of Randy Kaufmann (former Archive Chief at the Tageszeitung, Berlin), which consists of close to 1,200 posters from Berlin during the period 1978-1983; and the archive of the Sozialistische Deutsche Arbeiterjugend (the German Communist Party's youth organization), Landesvorstand Bremen, 1969/70-1983.

Besides these acquisitions, Peter Hein (Berlin) in collaboration with the ID-Archiv started an initiative for the creation of a 'Sammlung Berlin'. The thematic core of this archive is armed resistance, repression, justice and prison. At present, it consists of around 2,000 publications and the following important archives: Archiv der Roten Hilfe West-Berlin (incomplete), Druckwerkarchiv des Agit-Druck-Kollektivs West-Berlin, Knastarchiv des Verlags Schwarze Seele. The Sammlung Berlin is located in that city, but is owned by the ID-Archiv im IISG.

The 'Edition 1D-Archiv/Amsterdam-Berlin' is independent of the 1D-Archiv and 11SH, but works in close cooperation with both. In 1993, it published the following books:


THE NETHERLANDS PRESS MUSEUM

T his foundation was established in 1902 with the aim of documenting the history of the Dutch press, the oldest in the world. The Museum possesses more than 17,000 dossiers on and volumes of often rare newspapers, an extremely valuable collection of political prints and a number of archives in the field of Dutch media. From 1989, the NPM has been housed in the IISH building following a user and cooperative agreement between both organizations. The printed collections have since been made accessible through the Institute's computer system.

In 1993, the NPM organized two exhibitions: 'Van Binnenhof naar buiten: parliament and the press since 1795', and a major retrospective on Albert Hahn in the National Trades Union Museum. For this exhibit, the Hahn collection was (re)inventoried by staff at the Press Museum in early 1993. The collection consists of around 3,600 original political drawings, tens of photos and letters and a further 2,000 original designs, varying from book covers and posters to floats and tableaux vivants. Simultaneously, Thomas Rap publishers issued Marien van der Heijden's Albert Hahn. This richly illustrated book was prepared and financed by the NPM with support from different companies and funds.

The exhibitions shows that Albert Hahn left a far more varied oeuvre than is usually supposed. Besides his political prints, it also contains a large number of designs for the labour movement, including posters and brochures, flags and banners, podium decorations and tableaux vivants. Less well known is Hahn's non-political work, such as

advertising graphics for industry, the theatre and museums and his book-covers. The majority of these original designs has never been exhibited before.

On May 4, the (re)unveiling took place of a memorial tablet commemorating the staff of De Arbeiderspers who lost their lives during the Second World War. The monument was designed in 1955 by Nic Jonk and for years hung in the 'Rode Burcht' (Red Fortress) building on Hekelveld until it was pulled down. The memorial table has been passed on to the Persmuseum/IISH by the Rotter-

dams Dagblad.

The Persmuseum bought three original drawings by Hahn, the reproduced 'Bekende Tijdgenoten' (Famous Contemporaries) series by Jan Veth and volumes of a number of exceptional 17th-century periodicals. Furthermore, Vas Diaz donated a fine stained-glass window which portrays the history of this press agency. Finally, the Museum received ten archive books from the estate of Evert Werkman from his daughters Willemien and Luberta. The books provide a fascinating insight into the Algemeen Dagblad during the war years.

THE SAMPLING DUTCH POPULATION PROJECT (HSN)

The HSN is an initiative of a number of researchers from various social and historical disciplines. Its main task and aim is the creation and administration of a database with individual data based on a sample of 19th-century birth certificates preserved in public archives. More or less comparable projects have been ongoing abroad for some time. Extremely large databases already exist especially in Sweden (Stockholm and Umea) and Canada (Montreal and Chicoutimi). The HSN is a private foundation housed in IISH.

A test study of a limited number of samples provided insight into the feasibility of this aim. It was carried out

in the province of Utrecht and consisted of a sample of around 3,650 people from the period 1812-1922. Besides data on the birth certificates, information was also collated from death and marriage certificates and the population register. In general, the test study met expectations. An important aim was discovering in how far it was possible to find the death certificate of one of the people in the study whose death had occured at a time when the population administration did not function efficiently. It proved possible to find the death certificates of more than 90 percent of the sample. Besides birth and death certificates, a large number of marriage certificates were also input and dossiers were created on the sample subjects' migratory patterns.

Based on the results of the test study, it appears feasible to expand the sample to the whole of the Netherlands. It will cost f_{2M} and 10 years to create and maintain such a database for the whole of the country. This is below the original estimate, primarily because of a decline in hardware costs and the possibility of using personnel from the

job pool to carry out the input.

Besides the actual input work, the project's rapid expansion can also be counted a success. This has taken on concrete form in the shape of five follow-up projects. The Ministry of Education & Sciences provided an additional subsidy for the expansion of the HSN project. A further project was set up in collaboration with the Medical Computer Sciences and Epidemology Department of the Catholic University of Nijmegen, which uses the hsn database and infrastructure as a base. A researcher was appointed in cooperation with the Posthumus Institute to carry out further work on the Utrecht data. Sealand's Regional History Foundation will cooperate in the creation of an hsn database for that province from 1994. And a cooperative agreement has been made with the University of Nijmegen History Department for the col-


lection and administration of data from eight selected areas according to the HSN concept. Based on these projects, the continuity of HSN is guaranteed until 31 March 1996. Research on the Utrecht database is carried out by Jan Kok, and the project is headed by Kees Mandemakers.

THE NETHERLANDS ECONOMIC HISTORY ARCHIVE

The Netherlands Economic History Archive, an association established in 1914, can be seen as the parent of IISH, which began its work in 1935 with the NEHA'S historical collections as a base. Besides a large number of business archives, which have been given to municipal or state institutions for safekeeping since the 1970s, the NEHA also has a major book collection, the Economic History Library, which can compete with the best in the world. In 1989, the Archive moved into the Institute's building and the Ehb's collection has since been made accessible through the central computer system.

In the reporting year, the NEHA again pursued its aims – the collection, preservation and processing of source material and literature that can be considered of importance for economic and social history; for the pursual and stimulation of research in these disciplines, and the promotion of publications in this field – through a broad variety of activities. The collections were expanded considerably thanks to donations and contributions.

In total, the Neha generated 25 publications (including reports). Research on the history of the Dutch guilder and the Amev insurance company was continued. Both projects should be completed in 1994. A two-year project was started on the Nationale-Nederlanden insurance company. Furthermore, the Bureau Industrial Heritage (PIE) has commissioned research on selection problems in business archives. During study days and congresses both


at home and abroad, NEHA staff gave presentations on selection problems, administration of and access to business archives. Contacts with the world of research, archives and industry were intensified.

The Neha's extensive Registration of Business Archives (BARN) project was officially rounded off with the presentation of the complete series Historische Bedrijfsarchieven (Historical Business Archives, 16 volumes) to representatives of the ministries of Education & Sciences, Culture, and Economic Affairs. The complete series comprises data on over 5,000 archives, arranged by sector. In addition, provisional plans were developed for the future realization of further expansion of the economic history infrastructure with support from industry and government. Jacques van Gerwen gained his PHD on 12 January 1993 with a history of De Centrale.

THE N.W. POSTHUMUS INSTITUTE

Since 1991 IISH has participated in a national framework of university institutes and departments of social and economic history. This network came into being in 1988, initially in order to formalize and coordinate PHD-courses, a formula which was until then highly unusual in the Netherlands. After some years the loosely-knit network also wanted to coordinate research; in addition, it had begun to attract Flemish students and international seminars (called ESTER-seminars) in its field. Therefore, and because of the fact that IISH started to tutor its own PHD-students from 1992 onwards, already existing contacts between IISH and the centre – in the meantime changing its name to 'Institute' – were formalized.

From 1993 the Posthumus Institute coordinates four research programs, of which 11sh participates actively in two. Most important is the 'Changing labour relations and the family household' program. Besides 11sh-re-

searchers Jan Lucassen, Marcel van der Linden and Erik Zürcher, Jan Kok has a special position in this program. He studies the relationship between horizontal and vertical mobility during the 19th and early 20th centuries based on the HSN database. The second program is called 'Entrepreneurs in Early-Modern Dutch Trade and Commerce'. IISH projects on trade guilds fit within this framework.

On the basis of this research coordination, the N.W. Posthumus Institute now is in the application process of recognition as a research facility by the Royal Academy.

THE NATIONAL TRADES UNION MUSEUM

This museum, opened in 1991, works closely with IISH. During 1993, in addition to the semi-permanent exposition on union pioneer Henri Polak, exhibitions were devoted to the legendary rail strike of 1903, the artist Marie de Roode-Heijermans, and to union flags and banners. All of them made use of the Institute's collections. In December, a major show on political cartoonist and artist Albert Hahn, organized by NPM, was opened in the museum. The amount of publicity generated by these activities was cause for satisfaction.

In contrast to a national trend in declining museum visits, the number of visitors rose. With a total of 11,240 visitors in 1993, the young venue has already achieved a considerable ranking among the so-called small museums. The museum is also an increasingly attractive location for conferences, press conferences and presentations.

A series of successful symposia was continued (this year on dismissal rights and the flexibilization of labour) and literary-cultural activities included lectures by writer A.F.Th. van der Heijden and on author Multatuli, architect H.P. Berlage and painter Herman Heijenbrock.

A feasibility study on the possibility of renovating the architecturally splendid former headquarters of the

Dutch General Diamond Workers Union, which is now home to the museum, was concluded. The aim of returning parts of the building to its original state proved feasible. Options for the phased completion of this work are being sought.

The National Trades Union Museum's Henri Polak chair was inaugurated at the University of Amsterdam. Associate professor P. Vos commenced his lectures on the social significance of the union movement in October.

Moreover, in the reporting year, agreements were reached with 12 academic authors, Welboom Publishing and Brouwer Printers for a series of publications on various social questions involving the trade union movement. The first volume will appear in March, 1994.



HISTORY AND ACTIVITIES

Although the Institute was established in 1935, its history begins in the 1920s. During that period, Nicolaas Wilhelmus Posthumus (1880-1960) ranked among the pioneers of modern economic history in the Netherlands. In 1913, he was appointed to the first chair in this field and in the same year set up the Netherlands Economic History Archive (NEHA). It would be the first of a staggering 15 institutions he initiated. The NEHA concentrated on the preservation of archives of companies and related organizations, and on the collection of other sources relevant to economic history. The growth of the number of book and other printed matter in this archive led to the establishment of the Economic History Library (EHB) in 1932. Posthumus was a collector with a broad vision and included materials from individuals and organizations in the Dutch labour movement.

At the beginning of the 1930s two independent developments made the establishment of the International Institute for Social History desirable. First, the social-historical collections present in NEHA demanded a separate approach. Second, the political situation in Central and Eastern Europe was worsening. Hitler's seizure of power and developments in the Soviet Union threatened people of all convictions within the labour movement, as well as their collections. Posthumus was dedicated to saving their papers as he was sure they would be destroyed if they fell into the wrong hands, or in the most favourable case would no longer be accessible to independent researchers for many years.

He envisaged an independent, neutral, scholarly Institute and was fortunate to meet Nehemia de Lieme, director of De Centrale insurance company, which had close ties with the Social-Democratic movement. This company's statutes required the donation of a part of its profits to cultural aims of the labour movement. De Lieme became convinced of the importance of Posthumus' initiative and De Centrale supported the Institute on an extraordinary scale in the years preceding 1940.

In the period 1935-1940, attention was focused on saving material from all over Europe. The most important collection acquired in this period was the archival legacy of Marx and Engels. The Institute's extremely active first librarian, Annie Adama van Scheltema-Kleefstra, actually smuggled Bakunin manuscripts (part

of the famous Nettlau collection) out of Austria, just getting out before the Nazis marched into Vienna. Libraries and archives of Mensheviks and Social-Revolutionaries who had fled Russia were also brought to Amsterdam. The list of major acquisitions is too long to be included here, but mention should be made of the records of the CNT and the FAI: only weeks before Franco took the final Republican areas in Northern Spain in May 1939, they were brought to safety over the Pyrennees.

SECOND WORLD WAR

Posthumus' far-sightedness had led him to set up a subsidiary of the Institute in Britain. The most valuable archives were taken there to safety when, following the Munich Agreement, it became clear that the threat of war would not stop at neutral Holland's borders. And Posthumus was proved right when only days after the country was occupied by German troops in May 1940 a group of German functionaries presented themselves at the Institute's door. On July 15, IISH was closed by order of the Sicherheitsdienst. Staff were sent home and the Einsatzstab Rosenberg moved in.

Although many materials had been taken to safety, the library alone still comprised around 300,000 titles. A number of very important Dutch archives were also still located in the Institute, including those of sections of the SDAP (the Social-Democratic Labour Party). German bureaucracy was divided on the collection's fate. Over time, parts were shipped to Germany to be used for a variety of purposes. In September 1944, the remainder was removed and shipped east on board 12 Rhine barges.

The major part was only rediscovered in 1946 near Hannover in the English zone of Germany and returned to Amsterdam. Other material, which was located in the Soviet zone of Europe, was returned with less alacrity; the SDAP archive was ultimately sent back from Poland in 1956-1957. In 1991, following the failed coup in Moscow, other IISH materials proved to have been preserved for years in a separate archival institute in the Soviet capital.

RECOVERY

It would be 10 years before the Institute was back to normal. When the damage was surveyed after 5 May 1945, it turned out that litterally everything had been removed; there was no catalogue, no furniture, no filing cabinets etc. This was another reason why it took a long

time to determine what has been lost from the collection. Although every loss is a painful affair, it appeared that the extent was relatively

During the 1950s, 11SH worked to reestablish order in the archive and library. The financial situation was problematic, since De Centrale was no longer able to subsidize the Institute's work in the way it had before the war. With assistance from the University of Amsterdam, the City of Amsterdam and moneys received from the Wiedergutmachung fund, the Institute gradually began to recover.

In the 1960s and 1970s, the Institute benefitted from the growing interest in the history of social movements and ideas. It resumed its old task of saving the archives and libraries of persecuted people and organizations. This is how Amsterdam became home to material from Latin America in the 1970s. In the 1980s, action was taken to provide a safe haven for the collections of Turkish parties, trade unions and people. The Turkey Section, established in 1987, has already created an important collection. A final example of this type of work concerns the documentation of the Chinese democratic movement in the spring of 1989. It was collected by the participants in the events in Beijing, with the assistance of 118H staff on the spot. After the army had put a violent end to the democratic aspirations of the Chinese, the collection of pamphlets, phorographs, newspapers etc was brought to safety in Amsterdam.

The Institute now holds close to 2,000 archival collections, some 1m printed volumes and about as many audio-visual items.

Since the late 1970s, the Institute is working within the framework of the Royal Netherlands Academy of Arts & Sciences.


