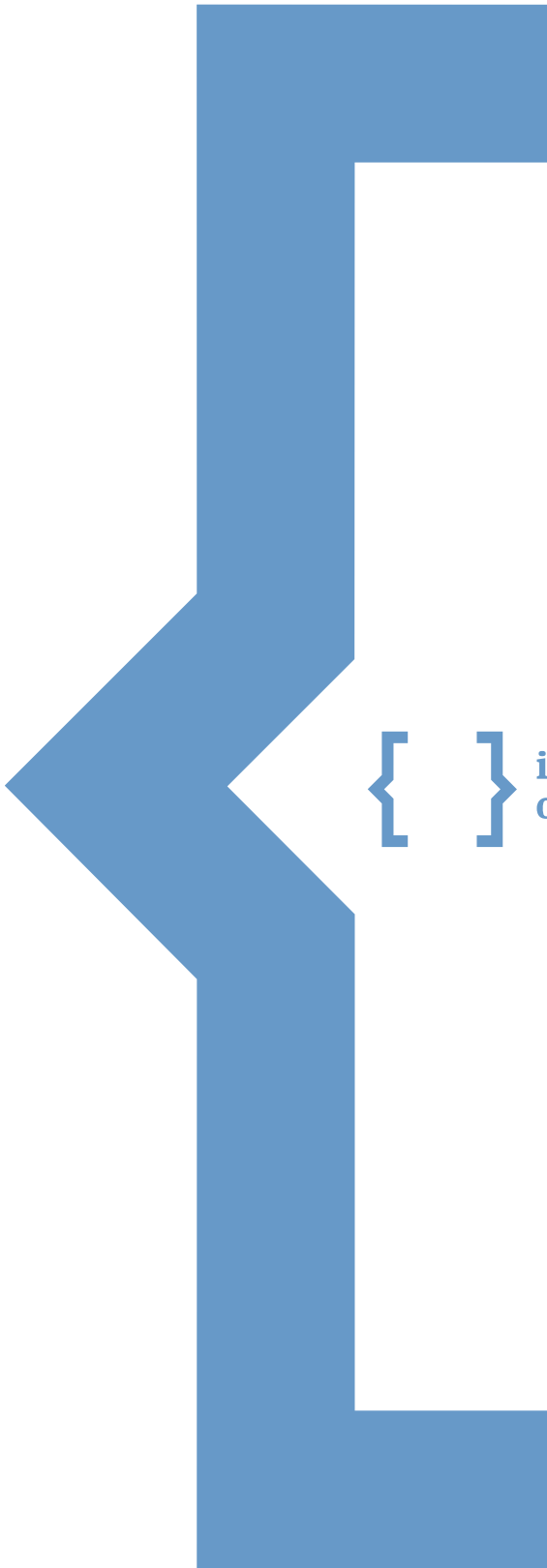

General Survey

In the history of the IISH, 2012 will go on record for the rather drastic change of course during that year. Previous annual reports had already suggested that the Institute was in trouble. One problem was the rapidly deteriorating financial situation, which in 2012 culminated in an ongoing annual deficit exceeding half a million euros. Moreover, the reorganization carried out in 2010 of the Collections Department proved unsatisfactory, while the Research Department lost some of its top researchers and was unable to replace them due to the financial situation. In addition, in 2012 the international committee that conducted the sexennial peer review published its report.¹ The committee expressed great praise for the research conducted at the Institute but was critical of its collection policy, which, according to the committee, was causing ‘unbridled growth’ of the paper mass present in the building. While this last opinion merits qualification, other signs also make clear that the international collection development policy of the IISH has less support than it once did in the Netherlands.

In October the board of the Royal Netherlands Academy of Arts and Sciences (KNAW) and the director of the IISH, Professor Erik-Jan Zürcher, decided that his first regular five-year term of appointment would not be followed by a second term. Professor Zürcher left immediately, and I, having previously worked at the IISH from 1982 until 2005 as deputy-director and having served for the past six years as director of the Huygens Institute of the History of the Netherlands in The Hague, was asked by the board of the KNAW to step in as director of the IISH. Soon after my start in November it became clear to me that the Institute will not escape rather drastic cuts to restore the balance between income and expenditure. Difficult choices lie

ahead regarding the tasks the IISH can continue to perform in the future. In 2013 there will be another reorganization, which will be based on a new strategy memorandum.

In May the board of the KNAW presented the memorandum *De contouren van een Vernieuwings- en stimuleringsprogramma van de Geesteswetenschappelijke instituten van de KNAW* [Contours of an innovation and encouragement program at the Humanities institutes]. The memorandum describes an ambitious programme for collaborative efforts between the Academy's humanities institutes, intended to achieve scale expansion and to enhance the quality of its support and collection management. The board formed a steering group of the directors of the institutes concerned (DANS, Huygens ING, IISH, Meertens Institute, NIAS, and NIOD) to crystallize the plans. In April 2013 the steering group will issue a report. In 2012 the Institute staff members worked under difficult circumstances. In addition to the nuisance of noisy and extended construction, they coped with organizational shortcomings and staff turnover. The innovation plans of the KNAW and the dismal financial situation were sources of insecurity. In August Jaap Kloosterman resigned from the position he had accepted in January as acting head of Collection Processing & Services. He was succeeded by Afelonne Doek, who also runs the Digital Infrastructure Department. After I arrived in November, Jaap Kloosterman agreed to serve as acting head of Collection Development through 2013.

Remodelling the stacks was completed in 2012, after which the material temporarily stored elsewhere was returned. Meanwhile, cataloguing new collections resumed, after having been prevented in 2010 and 2011 due to system replacements, remodelling, and a reorganization. The backlogs in processing accumulated over the years were assessed.

In 2012 the Institute acquired 184 new paper collections from all over the world (including accruals to existing collections). One of the larger among them is the archive of the International Council on Social Welfare, which was founded in 1928.² Another noteworthy collection was the literary legacy of Sal Santen (1915-1998), a Dutch revolutionary and writer, whose political archive had previously been received at the IISH. Altogether, the IISH received 338 metres of archive materials.

In early 2012 the new IISH website was launched. Unfortunately, this did not increase the number of virtual visitors, which went from 2.1 million in 2011 to 1.1 million in 2012. Factors that merit consideration include the new system for counting the visits, as well as the outsourcing of hosting the popular website *chinese posters.net*, so that it no longer figures in the visit count. Offsetting the decline in website visits, the number of physical visitors to the reading room increased from 4,820 to 5,261. This trend is expected to reverse, once the IISH makes its digitized (and digitally acquired) collections available via its own website. At this time, parts of the IISH digital collection are accessible only via Europeana and Het Geheugen van Nederland. These websites, however, do not cater to researchers but target a more general public.

The Institute has been digitizing the most important collections for years to prepare digital access for research purposes. In 2012 a vast financial contribution from SNS Reaal facilitated the start of digitizing the core collections acquired in the 1930s for the IISH by the Centrale Arbeiders Verzekerings- en Depositobank (a predecessor of SNS Reaal), including those of Karl Marx and Mikhail Bakunin. In addition, several parts of the collection were digitized in the framework of the national Metamorfoze conservation program. The IISH has been working with several partners on building a digital infrastructure to support scholarship in socioeconomic history. Thirteen institutions worked under the aegis of the IISH on the European HOPE project, which thanks to a substantial ERC subsidy provides for a joint repository for digital collections and for featuring the digital objects they contain in Europeana.³ In a team effort with Utrecht University, the IISH carried out the Clio Infra project, which is aimed at forming a hub for data sets concerning economic and social history.⁴

In 2012 it became increasingly clear that the Global Labour History research program is exceptionally successful. The IISH research group's perspective has drawn a worldwide following relatively quickly. In early 2012 the international evaluation committee observed: *'The institute has played a crucial role in reorienting social history to a more global approach; indeed, it has led in advocating for, and showing the potential of, the transnational turn in the discipline of history.'* And: *'This is a paradigm-shifting development, which for the first time in two decades*

has given a sense of innovation and importance to the discipline of labour history more broadly.'

The research group officially launched a partnership with Harvard University's *Weatherhead Initiative on Global Labour History*, with a view toward setting up a joint Global Labour History network. No less than three eminent international scholarly journals devoted special issues in 2012 to the research field pioneered by the IISH, expressing great praise for the IISH and especially for research director Marcel van der Linden.

In 2012 the research group was allocated external research grants totalling 1.3 million, including an NWO-Vidi grant for Dr Elise van Nederveen Meerkerk. Her decision to transfer to Wageningen University to run her own group at the end of the year is a loss for the IISH. Professor Jan Lucassen's retirement similarly counts as a loss. His achievements for the IISH – in part as leader of research from 1993 to 2001 – have been truly exceptional. The IISH is fortunate that both Elise van Nederveen and Jan Lucassen will remain affiliated as honorary fellows.

In the coming year the IISH will carry on under difficult circumstances, but the ample signs of zeal justify optimism about the chances of a quick recovery. The future lies in transnational socioeconomic historiography, digital collections, and state-of-the-art technology for processing and making them accessible and for analysing them. In 2013 the Institute will start crystallizing this future with new confidence.

Social Survey

At the end of 2012 the IISH employed 120 staff members.

The majority (78) works for the Royal Netherlands Academy of Arts and Sciences (KNAW), including 74 permanent employees, and 4 with temporary contracts. The IISH Foundation employs nearly all 37 temporary staff and a small number of permanent staff (7), including 3 with permanent contracts under entry/progression arrangements. One person has been seconded here, and 4 work as participants in a job experience program.

This year a change of the guard took place: on 31 October 2012 Erik-Jan Zürcher left the Institute and Henk Wals was appointed director of the IISH on 1 November 2012.

Most staff members work part-time, the ratio of part-time to full-time staff is 66:34. Men remain in the majority (57%). They are also overrepresented in the top and the bottom salary grades, while women continue to prevail in the middle grades. In 2012 the average age was 49.6.

Fourteen new staff members were hired in 2012. A total of 22 staff members left the Institute, among whom 9 had held permanent employment contracts.

The rate of absenteeism for 2012 is 5.92%, which is lower than it was last year, thanks to a reduction in long-term absenteeism with respect to last year's rate of absenteeism (6.63%).

In 2012 the administration met 6 times with the Staff Council (oc). The ambience at the meetings was cordial.



Research

Major Developments

In January, the findings from the evaluation of our Institute were published in a report filled with praise for our research activities. According to the committee we have ‘taken a leadership role in global academic discourse,’ and this has made us a ‘world player’ with ‘world-class research’ and research output that meets ‘the highest standard.’

Interest in our global approach to labour history continued to grow during the past year. Our collaboration with Harvard University’s Weatherhead Initiative on Global History, aimed at building a Global History Network, was formalized, and we have started to exchange PhD students across the Atlantic Ocean. Soon, we hope to expand the network to include research centres in Africa, Latin America, and Asia. In La Paz, in her native Bolivia, our colleague Rossana Barragán organized the country’s first conference about labour history, with one day devoted entirely to Global Labour History.

In Italy an association dedicated to the study of labour history was established, which at its founding conference paid serious attention to our research programme. At the Central European University in Budapest, a program oriented towards Global Labour History was launched.

Our collaborator Christian De Vito published an Italian collection of essays and an article in *Passato e Presente* on Global Labour History. The US journal *International Labor and Working-Class History* devoted a significant part of its 40th anniversary issue to a discussion on a manifesto written by our Research Director on ‘The Promise and Challenges of Global Labor History,’ and the French journal *Le Mouvement Social* featured the same topic in the special issue ‘Travail et Mondialisations.’ The international resonance of our work

was also reflected in three Chinese and Korean translations of books previously published in English by staff members.

Conferences

We have organized a great many scholarly events, highlighting the importance we attribute to infrastructural services. A selective list includes the European Social Science History Conference (ESSHC) in Glasgow with some 1,300 participants (coordinated by Els Hiemstra and her team) and conferences on the history of Exile (Ulla Langkau-Alex), on global inequality (Reinoud Bosch), on real wages (Pim de Zwart and Jan Luiten van Zanden), on shipbuilding (Raquel Varela), on convict labour (Christian De Vito and Alex Lichtenstein), and on mercantile networks (Ulbe Bosma). The Global Collaboratory on the History of Labour Relations organized two workshops on Africa (in Addis Ababa and Amsterdam), four workshops on the Lusophone world (two in Lisbon, two in Amsterdam), an Ottoman/Turkish workshop in Istanbul, and a synthesizing conference in Amsterdam. Touraj Atabaki and his team organized the third annual Sadighi lecture, we had several panels at the World Economic History Congress in Stellenbosch, and Gijs Kessler organized an exhibition on the history of the family in twentieth century Russia.

Grants

Additional achievements include several research grants we have been awarded. Elise van Nederveen Meerkerk received a so-called Vidi grant (worth €800,000) from the Netherlands Research Foundation nwo; we received a grant of €218,500 for the Global Collaboratory on the History of Labour Relations from the Gerda Henkel Foundation (Germany), as well as some slightly smaller sums from a variety of other grant-giving institutions, adding up to roughly €1.3 million. Our scholarly output was good and included a substantial number of books, chapters in books, and articles in a wide range of peer-reviewed journals, such as the *Annales historiques de la Révolution française*, *Portuguese Studies*, the *New West Indian Guide*, *Continuity and Change*, *Feminist Economics*, and the *Indian Economic and Social History Review*.

The downside to these positive achievements was that we lost some very capable researchers. Jan Lucassen, one of the founders of Global Labour History, has retired, though he will continue to work with us as an honorary fellow. He received the substantial *festschrift* *Working on Labor: Essays in Honor of Jan Lucassen* (Leiden: Brill). Elise van Nederveen Meerkerk decided to transfer to Wageningen University but will remain an honorary fellow as well. Filipa Ribeiro da Silva accepted an attractive job offer in Macao. Due to the current financial problems, the vacancies that these scholars left behind have at this time been filled only in part.



Collections

Digital Infrastructure

The aftermath of outsourcing the office automation and introducing a new cataloguing system remained very demanding. In addition, work continued on several projects that were nearing completion. Some of these – especially HOPE (History of the People’s Europe, dedicated to joint provision of digitized collections) and Clio Infra (international datasets for reconstructing global inequality) – are complicated due to their scope and partnership structure. Setting up a Trusted Digital Repository has been identified as a top priority for the years to come.

Accessions

The Institute acquired 184 (accruals to) paper collections. The larger ones included the archive of the International Council on Social Welfare, founded in 1928, and accruals to the collections of Brunn-Harris-Watts, Amnesty International Netherlands, and the Nederlandse Vereniging van Journalisten. In addition, material was digitized in several places. Some particularly noteworthy acquisitions are:

- The collection of the Levensverzekeringmaatschappij Utrecht [Utrecht life insurance company], entrusted to the NEHA on standing loan. This is a very important old collection on the insurance industry in general and on life insurance in particular. In 1887 the first printed catalogue was issued, when the collection comprised 800 titles; upon the transfer the collection consisted of nearly 12,000 titles, the oldest one from the sixteenth century.
- The literary legacy of Sal Santen (1915-1998), a revolutionary and

author, whose political archive was already present at the IISH. Born in 1915 into a family of social democrats, Santen worked successively for the Onafhankelijk Socialistische Partij (1932), Revolutionair-Socialistische Arbeiderspartij (1935), Leninistische Jeugdgarde (1936), Groep van Bolsjewiki-Leninisten (1939), Bond van Communisten (1940), Comité van Revolutionaire Marxisten (1943), Revolutionair-Communistische Partij (1945), and the Fourth International (1952). In 1937 he married Bep Blaauw, the step-daughter of Henk Sneevliet. In 1960 and 1961 he was convicted for forging bank notes and identity cards for the Algerian National Liberation Front. In 1967 Santen left politics, but he never abandoned his revolutionary-socialist convictions; he became a full-time writer. This accession comprises the manuscripts of his books and other publications, Sal's correspondence with his wife Bep, including from Sal's period with the Fourth International in South America (1952-1953), scrapbooks, audiotapes of interviews, and the DVD *Sal Santen, Rebel* (1982), a motion picture directed by Rudolf van den Berg and awarded a Gouden Kalf.

- The papers of Johannes Agnoli (1925-2003). Born in Italy, Agnoli became interested in revolutionary fascism as an adolescent. He volunteered for the Wehrmacht in 1943, and was captured by the British and interned in a prisoner of war camp in Egypt. In Germany, he studied at the University of Tübingen from 1948 and joined the left wing of the SPD, which expelled him in 1961. He was a teacher at the Otto Suhr Institut in Berlin (1972-1991). His book *Die Transformation der Demokratie* was widely read by the extra-parliamentary opposition in the late 1960s and early 70s.
- The records of Petrol-İş, a leading trade union of oil workers in Turkey. Affiliated with Türk-İş, Petrol-İş is known for its leftist principles and well-established organization and institutionalization. The collection comprises a wide variety of documents from between 1990 and 2012.
- The archive of the Karen National Union from 1967 onward.
- Three library collections of the Filippijnengroep [Philippines group] Nederland, the Philippines Documentation Centre and EICMAS (Malaysia and Singapore).
- Scans of the proceedings of the Textile Labour Association in Gujarat, part of the Major Mahajan Sangh, the labour union established by Mahatma Gandhi in 1920 and presently in jeopardy. The material is from the years 1924-1929, 1933-1937, and 1990-1995.

- The records of the Republican Brothers of Sudan, a small but influential party. The Sufi Shaykh Mahmud Muhammad Taha founded the Republican Brothers in the 1950s as an Islamic reformist movement dedicated to tolerance, equality, and justice. Taha opposed Nimeiri, was arrested, and was subsequently executed in 1985; yet his execution helped precipitate the coup against Nimeiri. The Republican Brothers survived the loss of their leader, but have not been politically active since 1989. The IISH now owns an almost complete collection of paper records from the movement, as well as digitized audio material and photographs.
- Association of Repressed People 'Vozvrashchenie' (Return), Moscow. In March 2012 a large-scale digitisation project was started in Moscow of the unique collection of manuscripts of gulag-memoirs and related materials of the association and publishing house Vozvrashchenie, founded by ex-political prisoner and gulag-survivor Semen Vilenskii. The larger part of these memoirs have never been published. An essential element of the digitisation project is the compilation of an extensive set of meta-data on the collection, relating information on the manuscripts in the archive, the authors of the manuscripts, their interrelationships, and the way in which the manuscripts reached the association. Especially the latter is of great interest, as this is a collection the foundation of which was laid deep in the Soviet period (1960s), and over subsequent decades came to encompass well over 70 metres of shelf-space. Together, metadata and memoirs will constitute a formidable collection on the gulag and the reintegration of ex-prisoners into Soviet society after the destalinization of the 1950s and 60s.
- The collection of the Chilean Jorge Magasich. This is the library and archive of a political fraction of the Chilean MIR called Izquierda Socialista. It is a small and rich collection of 9 boxes that has to do with the political activism after the coup of Pinochet and the activists' network throughout Europe and Latin America from 1974 to 1982. Jorge Magasich is now preparing a history of Allende's government. He is a member of La Asociación de Detenidos y Desaparecidos.

Access

After several years in which reorganizations, remodelling, and transitioning to new systems consumed our efforts, processing material gradually got under way again. The backlog accumulated over that period was assessed. In addition, projections were made of the expected arrival of digital material in the coming years.

Preservation

Substantial consideration was given to accommodating materials stored elsewhere during the remodelling, and setting up the new stacks. Digitizing began on the collections acquired for the IISH prior to World War II by De Centrale Arbeiders Verzekerings- en Depositobank [Central Workers' insurance and deposit bank] and comprising some of our best-known archives, such as those of Karl Marx and Mikhail Bakunin. Several additional collections were once again digitized in the Metamorfoze national preservation program.

Services

Reading Room

Visits to the reading room and concurrent physical use of the collections increased slightly. This is remarkable, considering the nuisance that the remodelling work caused at the Institute virtually throughout the year. The number of – digital and analogue – copies commissioned increased as well.

About forty groups received guided tours, mainly students and participants at meetings at the Institute. To accommodate the overwhelming interest, an exhibition designed by our colleague Coen Marinus was featured about the history of the IISH.

In Memoriam Rena Fuks-Mansfeld

Sadly, Dr Rena Fuks-Mansfeld (*1930), Professor emerita of Jewish history at the University of Amsterdam, passed away on 27 November 2012. Thanks to her the rich Yiddish collections of the IISH were made accessible. In October 2012 Rena Fuks said goodbye to the IISH.

She had finished her *magnum opus* with a database of Yiddish letters in various IISH archives.

In 1995 Rena Fuks, one of the very few people in the Netherlands who knew Yiddish, joined the IISH staff as a volunteer. Her first job was to catalogue the Yiddish books and periodicals. These printed materials were classified in the so-called Yidishkayt collection, to be found as such in the IISH catalogue. In 2002, Rena Fuks completed the arrangement of the archive and documentation of the Algemeyner Yidisher Arbeyter Bund, the very first collection acquired by the IISH. Thereafter she inventoried the archives of James Guillaume, Charles Rappoport and Boris Yelensky.

More than once, she wrote about highlights she found in the archives, on the IISH website and in *On the Waterfront*, the magazine of the Friends of the IISH

Communications



Major Developments

In 2012 IISH staff members were featured in various newspapers and journals, and the Institute facilitated several radio and television broadcasts. A new corporate leaflet was produced, and at the ESSHC in Glasgow, the communications department built and manned a promotional booth, ensuring the visibility of the Institute for visitors throughout the congress.

The Institute organized various public debates at the Spui25 debating centre, including one about the politician Pim Fortuyn and another about the revolutionary Ferdinand Domela Nieuwenhuis. In recognition of History Month, dedicated to the topic 'Rich and Poor', an evening debate was organized to discuss the question 'Why is Africa poorer than the rest of the world?'

In December 2012 the Volkskrant-IISH thesis award for the best history essay was presented for the third time. Submissions again outnumbered those from the previous year. This year the winner was the archaeologist Floris Keehnen, who received high marks for his essay *Trinkets (f)or Treasure? The role of European material culture in intercultural contacts in Hispaniola during early colonial times.*

The Institute was active in various social media. IISH photographs posted on Flickr were clicked over 900,000 times. And the number of followers on Twitter and Facebook increased considerably.

The Institute was also active on youtube, scribd, pinterest, and librarything-books.

Website

In early 2012 the new IISH website was launched, featuring an entirely new layout and structure, as well as the web address socialhistory.org. The new CMS facilitates adding news and enhances public access to the website.

Sections of the website, such as the publications, regional desks, and the item of the day, have been redesigned. The ESSHC congress has been given a new subsite at socialhistory.org. In transitioning to a new system, the web statistics have been registered differently as well.

In 2012 the website once again featured news reports, staff publications, congresses, and collection presentations. Special presentations included posters of the Melkweg and Paradiso music halls, picture postcards from the first holiday weeks for workers, a list of Yiddish letters in the IISH collections, and posters elaborating on the 'Your Country Needs You' theme.

Friends of the IISH

The Friends' Day held on 26 January 2012, was dedicated to *Women's Work*, a major research project for which the Friends of the IISH appropriated the funds in February 2002. On the Friends' Day held on 11 June 2012 IISH colleague Frank de Jong screened *Toegemuurde Verten* [Sealed Horizons], a propaganda film produced for the Dutch Christian Industry and Transport Workers' Union in 1936. At both meetings a selection of recent acquisitions was presented.

On 17 November 2012 the Drents Museum in Assen opened an exhibition that owes its very existence to the Friends of the IISH. *Together and Apart* is an exhibition on the social history of Russia in the twentieth century. Featuring a family perspective, it offers a view from below. The exhibition was part of the project *Work, Income and the State in Russia and the Soviet Union, 1900-2000* which was funded by the Friends and supervised by the exhibition curator and IISH researcher Gijs Kessler.
